



# Personalization of Learning through Technology (PLT) *iPad Protection Plan*

---

**South Washington County Schools (ISD 833)** recognizes with the implementation of our iPad 1:1 efforts there is a need to protect the investment by both the district and the family. The participation cost for those choosing to enroll in the iPad Protection Plan is \$35 per device. The iPad Protection Plan will have a family maximum cap of \$100 based upon the enrollment of more than two students for families with multiple students. Payment is due upon issuing of the student's iPad.

The iPad Protection Plan provides coverage for accidental damage (drops/spills), cracked screens, theft (with a filed police report), fire, flood, natural disasters, and power surges due to lightning. The \$35 fee payment is **nonrefundable**. This annual coverage begins upon receipt of the payment and ends at the conclusion of the scheduled school year.

#### **The iPad Protection Plan does not cover:**

- Lost or intentionally damaged iPads
- Charging cable, power adapter "brick" and cases that are lost, stolen or damaged
- Damage to the iPad while the case is not appropriately on the iPad

#### **Cost for replacement of iPad accessories:**

- Apple Lightning to USB charging cable - \$20
- Apple USB Power Adapter charging "brick" - \$20
- iPad Protective Case - \$35

The iPad Protection Plan does not have a co-payment deductible iPad repair/replacement fee for the **first** incident of damage or claim within the academic year. However, a co-payment deductible repair/replacement fee is **required** for multiple incidents or claims made during the same period of coverage for the selected iPad Protection Plan.

#### **iPad Protection Plan Repair/Replacement Fee Deductible Schedule:**

- 1st incident /repair claim - \$0
- 2nd incident /repair claim - \$165
- Additional incidents /repair claims - \$165 and iPad privileges lost

**All iPad Protection Plan claims must be reported to the Media Specialist of your child's school within 72 hours.** In cases of theft or other criminal acts, a police report, or fire report in the case of fire, MUST be filed by the student or parent for the protection coverage to be utilized. A copy of the police/fire report must be provided to the Media Specialist at your school.

Families who waive the iPad Protection Plan option will be held responsible for **ALL** damage to the district iPad(s) including, but not limited to: broken screens, cracked or damaged casing or components, damaged ports or buttons, inoperability from jailbreaking, etc. Stolen or lost iPads or accessories such as cases, cables and power adapters will be charged the actual replacement cost.

**INTENTIONAL DAMAGE:** The School District iPad Protection Plan DOES NOT cover intentional damage to the iPad. Students/parents are responsible for full payment of intentional damages. This includes any damage to the iPad if the iPad was not in the FULL protective case issued by the district.

#### **Note:**

- Families who **waive** the iPad Protection Plan will be responsible for the full cost of repair or replacement of the iPad.
- The district issued iPad accessories, charging cable, power adapter "brick" and case are **not covered** by the iPad Protection Plan and remain the responsibility of the student/family.
